# LIMITS, FINES & POINTS QUESTIONS

## 1. If you are convicted of failing to remain at the scene of a collision, \_\_\_ demerit points will be added to your driving record.

#### 7

70 CI EXAM ------

If you are convicted of failing to remain at the scene of a collision, seven demerit points will be added to your driv ing record. The most points you can gain for a single of fence is seven.

## 2. If you are convicted of following too closely (tailgat ing), \_\_\_ demerit points will be added to your driving record.

#### 4

If you are convicted of following too closely (tailgating). four demerit points will be added to your driving record.

### **3.** If you are found guilty of \_\_\_\_\_, three demerit points will be added to your driving record.

#### **IMPROPER PASSING**

If you are found guilty of improper passing, three demerit points wil I be added to your driving record.

## 4. If you are found guilty of carrying a child passenger who is not properly secured, \_\_ demerit points will be added to your driving record.

#### 2

If you are found guilty of failing to secure a child passenger in an appropriate child restraint or booster seat, two de merit points will be added to your driving record. The few est points you can gain for a single offence is two.

## 5. A new driver has up to \_\_\_\_ to complete the graduated licensing process.

#### SYEARS

You have up to five years to finish the graduated licensing process. If you still haven't obtained your full G licence af ter five years, you will have to start the whole process over again.

## 6. If a new driver accumulates <u>demerit</u> demerit points on his or her driving record, he or she will be sent a warning letter.

#### **2TOS**

If a new driver accumulates between two and five demerit points on his or her driving record, he or she will be sent a warning letter. Note that a conviction for any offence cov ered by the demerit point system will earn the driver at least two points.

### 7. How many passengers is a G2 driver who is at least20 years old allowed to carry in his or her vehicle?

### AS MANY PASSENGERS AS THERE ARE WORKING SEATBELTS

A G2 licence holder who is at least 20 years of age is al lowed to carry as many passengers as there are working seatbelts in his or her vehicle.

#### 8. You must hold a G2 licence for at least \_\_\_\_\_ before you may take the G2 (Level Two) road test for a full G licence.

#### 12MONTHS.

After you've held a G2 licence for at least twelve months, you may take a G2 (Level Two) road test to qualify for full driving privileges. You must pass this test to get a full G licence.

## 9. What must you bring to your G2 (Level Two) road test for a full G licence?

#### **YOUR G2LICENCE**

Obviously, you must have your driver's licence with you whenever you drive.

### **10.** You may NOT park within \_\_\_\_ metres of the near est rail of a level railway crossing.

#### 15

You may NOT park within 75 metres of the nearest rail of a level railway crossing.



### **11.**Do NOT park anywhere that you don't have a clear view for at least \_\_\_\_\_ metres in both directions.

#### 125

Do not park on a curve, on a hill, or anywhere else that you don't have a clear view for at least 725 metres in both directions.

## **12.** If you are convicted of violating Ontario's Move Over law, you will face which of the following penal ties for a first offence?

### A FINE OF\$400-\$2,000AND THREE DEMERIT POINTS

If you are convicted of violating Ontario's Move Over law, you will be fined between \$400 and \$2,000 and gain three demerit points for a first offence.

### **13.** If you are convicted of violating Ontario's Move Over law for the second time within 5 years,

#### YOU WILL BE FINED\$1,000-\$4,000AND FACE A POSSIBLE JAIL SENTENCE AND A POSSIBLE LICENCE SUSPENSION.

If you are convicted of violating Ontario's Move Over law for the second time within 5 years, you will face a fine of between \$7,000 and \$4,000, a possible jail sentence of up to six months and a possible licence suspension for up to two years.

## **14.** A novice driver convicted of distracted driving is subject to \_\_\_\_\_ for a third occurrence.

#### LICENCE CANCELLATION AND REMOVAL FROM THE GRADUATED LICENSING SYSTEM

A novice driver (subject to the graduated licensing pro gram) convicted of distracted driving will be subject to es calating sanctions (30- day licence suspension for a first occurrence; 90 days for a second occurrence; and licence cancellation and removal from the Graduated Licensing System for a third occurrence).

## **15.** If a fully licensed or hybrid driver is convicted of dis tracted driving for the first time, s/he faces

#### A FINE OF UP TO\$1,000AND 3 DEMERIT POINTS.

If convicted for the first time, a fully licensed driver (holder of Class A, B, C, D, E, F, G) or a hybrid driver (holder of a full class licence and a novice licence such as Class G and MI) who talks, texts, types, dials, or e-mails using handheld cel lular phones and other handheld communications and en tertainment devices faces fines of up to \$7,000 and three demerit points applied to their driver's record under On tario's distracted driving law.

## **16.** A teenage G2 driver with more than 6 months of driving experience may carry <u>between midnight</u> andSa.m.

.....

#### UP TO THREE PASSENGERS AGED 19 OR UNDER

If you are 79 years of age or under and you've had your G2 licence for more than 6 months, you can drive with up to three passengers 79 or under between midnight and 5 a.m.

#### **17**.As a level one or two driver, if you collect nine or more points during a two-year period, your licence will be suspended for

#### 60DAYS.

As a level one or two driver, if you collect nine or more points during a two-year period, your licence will be sus pended for 60 days and you must surrender it to the Min istry of Transportation. You can lose your licence for up to two years if you fail to surrender it.

## **18**. Drivers who don't follow the stopping require ments at a school crossing may receive

#### A SUBSTANTIAL FINE AND 4DEMERIT POINTS.

Where a school crossing guard displays a red-andwhite stop sign, you must stop before reaching the crossing and remain stopped until all persons, including the school crossing guard, have cleared THE WHOLE ROADWAY and it is safe to proceed. Drivers who don't follow the stopping requirements may receive a substantial fine and get four demerit points ..

### 19. How close to a fire hydrant may you legally park? NOT CLOSER THAN 3 METRES (10FEET)

Do not park within 3 metres of a fire hydrant, on or within 700 metres of a bridge, or within 6 metres of a public en trance to a hotel, theatre, or public hall when it is open to the public.

## **20**. The Ministry of Transportation may suspend a licence after a 9 Demerit Point interview for a fully licensed driver

#### IF A DRIVER FAILS TO GIVE SATISFACTORY REASONS WHY THEIR LICENCE SHOULD NOT BE SUSPENDED.

As a fully licensed driver, you may have to go to an inter view to discuss your record and give reasons why your li cence should not be suspended. You may also have to complete a driver re-examination. If you fail this test, your licence can be cancelled. If you fail to attend an interview or fail to give good reasons for keeping your licence, it may be suspended.



## **21.** When a fully-licensed driver accumulates 15 or more demerit points on his/her record, the driver's licence is suspended

## AUTOMATICALLY, AND FOR 30 DAYS FROM RECEIPT OF THE LICENCE BY THE MTO.

Your licence will be suspended for 30 days from the date you hand it over to the Ministry of Transportation. You can lose your licence for 2 years if you fail to surrender it.

# 22. How soon after a licensed driver changes his/her name or address is he/she required to notify the Min istry of Transportation and Communications?

#### WITHIN 6 DAYS

If you change your name or address, you are required to notify the Ministry of Transportation and Communications within 6 days.

# 23. If you are found guilty of driving around a railway crossing barrier, <u>demerit point(s)</u> will be added to your driving record.

#### 3

There are many different offences that are worth three de merit points each. For example, if you are found guilty of driving through, around or under a railway crossing barrier, three demerit points will be added to your driving record.

## 24. If a fully licensed driver accumulates 6 demerit points on his or her driving record,

### THE DRIVER WILL BE SENT A WARNING LETTER.

If a fully licensed driver accumulates 6 demerit points on his or her driving record, he or she will be sent a warning letter.

## **25.** If you are convicted of a driving offence in another province,

#### DEMERIT POINTS WILL BE ADDED TO YOUR RECORD AS IF THE OFFENCE HAD OCCURRED IN ONTARIO.

You can gain demerit points if you are convicted of offenc es committed in New York State or Michigan as well as in any Canadian province or territory.

## 26. While you hold a GI licence, you may NOT drive between

#### MIDNIGHT AND 5 A.M.

While you hold a G7 licence, you may NOT drive between midnight and 5 a.m.

## 27. Do you have to be supervised by a more experienced driver when you're driving at night with your G2 licence?

## NO, YOU CAN DRIVE UNSUPERVISED AT ANY TIME OF THE DAY OR NIGHT.

After you pass your G7 road test, you'll get a G2 licence. With a G2 licence, unlike a G7 licence, you can drive unsu pervised on all Ontario roads and at any time of the day (in most cases). However, your blood alcohol level must still be zero whenever you're behind the wheel.

#### 28. If you have a GI licence and complete a govern ment-approved beginner driver education course, you may take your GI (Level One) road test after you've held your GI licence for at least

#### 8 MONTHS.

If you have a G7 licence and complete a government-ap proved beginner driver education course, you may take your G7 (Level One) road test after you've held your G7 li cence for just eight months instead of the usual twelve.

## 29. Both the GI (Level One) and G2 (Level Two) road tests will test you on

#### HOW SAFE YOUR DRIVING IS.

During each of the road tests, you will be tested on how well you manage the space around your vehicle, your abil ity to make safe lane changes and how closely you follow and stop behind other vehicles. You will be evaluated on how well you communicate with other road users, using turn signals and brake lights and making eye contact with pedestrians and other drivers. The correctness of your driv ing decisions (such as knowing when to yield the right-of way) will also be evaluated.

## **30.** To obtain a GI licence, you must be at least 16 years old and pass

#### AN EYE TEST AND A KNOWLEDGE TEST.

To obtain a G7 licence, you need to be at least 76 years old and pass an eye test and a knowledge test about the rules of the road and traffic signs.

## 31. You may NOT park within \_\_\_\_ of a bridge.100 METRES

Do not park within three metres of a fire hydrant, on or within 700 metres of a bridge or within six metres of a pub lic entrance to a hotel, theatre or public hall when it is open to the public.



## **32**. Under Ontario's Move Over law, you are required to change lane if safe when passing a stopped emergen cy vehicle...

#### WITH ITS LIGHTS FLASHING.

Under section 759 (2, 3) of the Ontario Highway Traffic Act, if you encounter an emergency vehicle or tow truck that is stopped with its lights flashing on your side of the road, you must slow down and pass it with caution. You must also move into a non-adjacent lane, leaving a vacant lane between your vehicle and the emergency vehicle or tow truck if it is possible and safe to do so. If you violate this law, you will be fined and gain three demerit points for a first offence.

## **33.** Failing to stop for a school bus that is unloading passengers will

## COST YOU 6 DEMERIT POINTS AND A MAXIMUM FINE OF UP TO \$2,000.

Failure to stop for a school bus that is unloading passen gers will cost you 6 demerit points and a maximum fine of up to \$2,000.

# 34. If an accompanying driver is older than 22, their blood alcohol level must be less than 0.05%.

A supervising driver must have his/her blood alcohol level of less than .05%. (If this person is 27 or under, their blood alcohol level should be zero).

# **35**. If you are convicted for the first time of driving while your licence is suspended, you will get an ad ditional six-month suspension, and you will also face which of the following other penalties?

#### EITHER JAIL TIME OR A FINE OR BOTH

If you are convicted of driving while your licence is sus pended for an HTA offence, you will have to pay a fine of \$7,000 to \$5,000 for a first offence. The court can order you to spend up to six months in jail, or you may have to pay a fine or do both. Six months will be added to your current suspension as well.

# **36.** Unless otherwise posted, the maximum speed limit allowed in cities, town, villages, and built-up areas is

#### SOKM/H.

Where there are no posted speed limits, the maximum speed is 50 km/h in cities, towns, villages, and built-up ar eas, and 80 km/h elsewhere.

## **37.** When lights are required, drivers must switch from high-beam lights to low beams when following another vehicle

#### WITHIN 60 METRES (200 FEET).

Use your low-beam headlights when following a vehicle within 60 metres. On country roads, switch to low beams when you come to a curve or hilltop so you can see on coming headlights and won't blind oncoming drivers. If you can't see any headlights, switch back to high beams.

## **38**. When lights are required, drivers must use low beam headlights

#### WITHIN 150 METRES OF AN ONCOMING VEHICLE.

Cut down glare at night by following the rules of the road for vehicle lights. Use your low-beam headlights within 750 metres of an oncoming vehicle.

## **39**. When passing a cyclist, leave at least <u>distance</u> between your vehicle and the cyclist.

#### **I METRE**

When passing a cyclist, drivers are required to maintain a minimum distance of one metre between their vehicle and the cyclist. If the lane is too narrow to share, change lanes to pass the cyclist.

## 40. Demerit points stay on your driving record for \_\_\_\_\_ from the date of the offence.

#### **TWO YEARS**

You start with zero demerit points on your driving record. You gain points for being convicted of breaking certain traffic laws in Canada, New York, or Michigan. Demerit points stay on your record for two years from the date of the offence. If you accumulate enough points, you can lose your driver's licence.

#### 41. Demerit points are added to your driving record only for offences committed in Canada. False.

Demerit points are added to your driving record if you are convicted of breaking certain driving laws. However, the consequences will depend on whether you're a new driver or a fully licensed driver. You can gain demerit points if you are convicted of offences committed in New York State or Michigan as well as in any Canadian province or territory.



#### 42. If you are convicted of driving at \_\_\_\_ km/h over the posted speed limit, four demerit points will be added to your driving record.

#### 30TO49

If you are convicted of exceeding the speed limit by 30 to 49 km/h, four demerit points will be added to your driv ing record.

## **43**. Fully licensed drivers are \_\_\_\_\_ to use hand-held cell phones while they're driving.

#### **NOT ALLOWED**

If you are convicted of driving while holding or using a hand-held wireless communications or entertainment device, three demerit points will be added to your driv ing record.

## 44. If you are found guilty of backing on a highway or driving too slowly, \_\_ demerit points will be added to your driving record.

#### 2

If you are found guilty of backing on a highway or driving too slowly, two demerit points will be added to your driv ing record. The fewest points you can gain for a single of fence is two.

### **45.** If you are under 20 years of age and have held your G2 licence for at least six months, you

### MAY CARRY UP TO THREE UNRELATED PASSENGERS AGES 19 OR UNDER.

If you are under 20 years of age, for the first six months that you hold a G2 licence, you may carry only one unrelat ed passenger who is 79 or under. After the first six months, you may carry up to three unrelated passengers who are 79 or under. Once you turn 20, you will be allowed to car ry as many passengers as there are available seatbelts in your vehicle. All these restrictions will be lifted after you ob tain a full G licence.

# **46**. If you fail to surrender your licence after it has been suspended for accumulating excessive points, you may lose your licence for up to

#### 2YEARS.

If your licence has been suspended for accumulating ex cessive points, you must surrender it either in-person at a ServiceOntario Centre or by mailing it to the Driver Control Section of the Ministry of Transportation. If you fail to do so, may lose your licence for up to two years.

## 47. A class GI, G2, MI, or M2 driver may be required to attend an interview to discuss his/her record and give reasons why their licence should not be suspended

### WHEN 6 DEMERIT POINTS HAVE BEEN ACCUMULATED.

See https://www.ontario.ca/laws/regulation/940339 and section "Demerit-point System for Level 7 and Level 2 Driv ers" in the official MTO Driver's handbook. Pay attention that the question refers to Level 7 and Level 2 drivers, NOT fully licensed drivers.

#### 48. GI licence holders may NOT drive

#### ON HIGH-SPEED EXPRESSWAYS UNLESS ACCOMPANIED BY A DRIVING INSTRUCTOR.

While you hold a G7 licence, you may not drive on 400-se ries highways or high-speed expressways (e.g., 407, Queen Elizabeth Way (QEW), Gardiner Expressway) unless accom panied by a driving instructor.

## **49**. While you hold a GI licence, your blood alcohol level may not exceed \_\_\_ whenever you're behind the wheel.

#### ZERO

While you hold a G7 licence, your blood alcohol level must be zero whenever you're behind the wheel.

## 50. You may NOT park within \_\_\_\_ of an intersection that is NOT controlled by traffic lights.

#### **9 METRES**

Do not park within 75 metres of an intersection that is con trolled by traffic lights or within 9 metres of an intersection that is not controlled.

#### 51. The penalty for improper HOV lane use is

#### A \$110FINE AND THREE DEMERIT POINTS.

Motor vehicle operators who use an HOV lane improper ly can be stopped and ticketed by OPP officers. The pen alty for improper HOV lane use is a \$770 fine and three de merit points.

#### **52.** Do NOT park wherever you would block

#### A SIDEWALK, CROSSWALK OR ROAD ENTRANCE.

Do NOT park wherever you would block a sidewalk, cross walk, pedestrian crossing or road entrance. Also don't park wherever you would block another vehicle that is already parked.



### **53.** If a fully licensed driver accumulates between 9 and 14 demerit points on his or her driving record,

#### THE DRIVER'S LICENCE MAY BE SUSPENDED, HE OR SHE MAY HAVE TO ATTEND AN INTERVIEW TO DISCUSS HIS OR HER DRIVING RECORD, AND THE DRIVER MAY HAVE TO PAY A \$50 FEE.

If you accumulate between 9 and 74 demerit points on your driving record, you may be required to attend an in terview to discuss your driving record. (You will have to pay

a \$50 fee for the demerit point interview.) At this meeting, you will have to provide reasons why your licence should not be suspended. If you do not attend or if your stated rea sons prove unconvincing, your licence may be suspended.

54. If you are a driver aged 19 or under and within the first six months of receiving your G2 licence, how many passengers are you allowed to carry between midnight and 5 a.m.?

#### I PASSENGER AGED 19 OR UNDER (NO RESTRICTIONS FOR PASSENGERS 20 AND OVER)

Please pay attention to how long a teenage driver has had the licence: if s/he is in his/her first six months, which is the case in this question, s/he is only allowed to carry7 passen ger aged 79 or under. After s/he has been a G2 driver for more than 6 months, the limitation is extended to 3 pas sengers aged 79 or under.

## **55.** When approaching a railway crossing at which an electrical or mechanical signal device is warning of the approach of a train, you must

## STOP NOT LESS THAN 5 METRES (15 FEET) FROM THE NEAREST RAIL

When approaching a railway crossing at which an electri cal or mechanical signal device is warning of the approach of a train, you must stop at least 5 metres (75 feet) from the nearest rail. Wait until the signal lights stop flashing, and if the crossing has a gate or barrier, wait until it rises before you cross the tracks.

## 56. When does the law require the headlights on vehicles to be turned on?

#### BETWEEN HALF ANHOUR BEFORE SUNSET TO HALF AN HOUR AFTER SUNRISE AND AT ANY OTHER TIME YOU CANNOT SEE CLEARLY FOR A DISTANCE OF 150 METRES (500 FEET)

Turn on the headlights one-half hour before sunset and keep them on until one-half hour after sunrise. You must always use the headlights when fog, snow, or rain keeps you from clearly seeing people or vehicles less than 750 metres away.

#### SZ When passing a cydist, failing to leave a minimum I metre between you and the cyclist may result in a fine and \_demerit point(s) on your driver's record.

#### 2

Failure to leave a required 7 metre between you and the cyclist when passing one may result in a fine from \$60 to \$ 500 and additional two demerit points on your driv er's record.

## 58. If you are convicted of \_\_\_\_\_, six demerit points will be added to your driving record.

#### FAILING TO STOP FOR A SCHOOL BUS, RACING, OR DRIVING 50 KM/H OR MORE OVER THE POSTED SPEED LIMIT

If you are convicted of careless driving, racing, failing to stop for a school bus or exceeding the speed limit by 50 km/hour or more, six demerit points will be added to your driving record.

## 59. If you are found guilty of \_\_\_\_\_, three demerit points will be added to your driving record.

## FAILING TO OBEY A STOP SIGN, TO REPORT A COLLISION OR TO YIELD THE RIGHT-OF-WAY

If you are found guilty of failing to obey a stop sign, traffic control stop/slow sign, traffic light or railway crossing sig nal, failing to report a collision or failing to yield the right of=way among many other offences, three demerit points will be added to your driving record.

## **60**. While you hold a GI licence, you may only drive with another driver who

#### HOLDS A FULL G LICENCE, HAS AT LEAST FOUR YEARS OF DRIVING EXPERIENCE AND IS THE ONLY PASSENGER IN THE FRONT SEAT.

While you hold a G7 licence, your driving must be super vised by another driver who holds a full G licence, has at least four years of driving experience, and is the only other person in the front seat.

## 61. A person whose driver's licence is under suspen sion, may

## NOT OPERATE A MOTOR VEHICLE UNDER ANY CONDITIONS.

You may not drive, under any circumstances, when your licence is suspended. [Driving Under Suspension, Other Ways to Lose Your Licence, Chapter 4 Keeping Your Driv er's Licence, The Official MTO Driver's Handbook]



## 62. If you are found guilty of going the wrong way on a one-way road, \_\_\_ demerit points will be added to your driving record.

#### 3

If you are found guilty of going the wrong way on a one way road, three demerit points will be added to your driv ing record.

## 63. All vehides must be insured for third-party liability for at least

#### \$200,000.

All vehicles must be insured for third-party liability for at least \$200,000. This covers you in the event that you injure or kill someone or damage someone's property while driv ing. Collision insurance to cover damage to your own vehi cle is a good idea, but not required by law.

## 64. As a Level 2 (G2) driver, your blood alcohol level must not be over

#### 0.00%.

Level 7 and Level 2 drivers must have a blood alcohol lev el of zero when driving. New drivers caught drinking and driving will receive a 30-day suspension and can also be charged under the Criminal Code.

### 65. If a police officer signals you to pull over and you do not obey, you might

### HAVE YOUR LICENCE SUSPENDED, PAY UP TO A \$25,000 FINE AND/OR SERVE TIME IN PRISON.

If you do not obey a police officer's direction to pull over, you risk being fined (up to \$25,000). having your licence suspended, or even serving time in prison. [Obey Police; 2. Driving Along; Safe and Responsible Driving; The Official MTO Driver's Handbook]

#### 66. New drivers caught drinking and driving will receive for the first occurrence.

#### AN IMMEDIATE DRIVER'S LICENCE SUSPENSION AT THE ROADSIDE FOR 24 HOURS AND, IF CONVICTED, A FINE OF UP TO \$500 AND A SUSPENSION PERIOD OF30 DAYS

Drivers of all ages in either Level 7 or Level 2 of Ontario's graduated-licensing system must also have a blood-alco hol level of zero when driving. New drivers caught drinking and driving will receive an immediate driver's licence sus pension at the roadside for 24 hours and, if convicted, will face a fine of up to \$500 and will receive a suspension pe riod as per the Novice Driver Escalating Sanctions scheme. For the first occurrence, you will be suspended for 30 days.

### 67. If you are convicted of careless driving, you will get six demerit points and can get

#### YOUR LICENCE SUSPENDED FOR UP TO TWO YEARS, A FINE OF UP TO \$2,000 AND A JAIL SENTENCE OF UP TO SIX MONTHS.

Police can also charge drivers with careless driving or even dangerous driving (a criminal offence) if they do not pay full attention to the driving task. If you are convict ed of careless driving, you will get six demerit points, can be fined up to \$2,000, and can be sentenced to up to six months in jail. In some cases, your licence may be sus pended for up to two years.

### 68. Under which of the following conditions is it dan gerous and unlawful to make a U-turn?

IN A CURVE OR ON A HILL, WITH A CLEAR VIEW OF LESS THAN 150 METRES (500 FEET) IN EITHER DIRECTION; ON A RAILWAY CROSSING, OR WITHIN 30 METRES (100 FEET) OF A RAILWAY CROSSING; AND WITHIN 150 METRES (500 FEET) OF A BRIDGE, VIADUCT, OR TUNNEL IF THE DRIVER'S VIEW IS OBSTRUCTED

Before you make a U-turn, check to make sure there is no sign saying not to. To make a U-turn safely, you must be able to see well in both directions. It is illegal to make a U- turn on a curve in the road, on or near a railway crossing or hilltop, or near a bridge or tunnel that blocks your view. Never make a U-turn unless you can see at least 750 me tres in both directions.

## 69. Which of the following penalties can the court im pose on a person convicted of driving 50 km/h or more over the speed limit?

#### \$2,000 TO \$10,000 FINE; JAIL TERM OF UP TO 6 MONTHS; LICENCE SUSPENSION UP TO 2 YEARS OR 6 DEMERIT POINTS.

If police stop you for driving 50 km/h or more over the speed limit, you will be charged with street racing. Po lice will suspend your licence on the spot and impound your vehicle for 7 days. If convicted for the first time, you will face penalties that include: \$2,000 to \$70,000 fine;jail term of up to 6 months; licence suspension up to 2 years or 6 demerit points.

#### 70. You must report an accident to the police if

#### SOMEONE HAS BEEN HURT OR KILLED, OR DAMAGE TO VEHICLES OR PROPERTY EXCEEDS \$2,000.

By law, you must report any collision to the police when there are injuries or damage to vehicles or property ex ceeding \$2,000.
